Installation Instructions for ISS-102C-M-LC Intrinsically-Safe Switch

The ISS-102 Isolated Switch has been evaluated by MSHA (18-ISA070001-0) as an associated apparatus for interfacing between hazardous and non-hazardous areas. The ISS-102 must be installed in a non-hazardous area. Consult MSHA for approval for use in any associated equipment, and follow SymCom's Control Drawing ISS-102C-M on the back of this sheet for proper installation.

All wiring connected to a hazardous location must be separated from all non-intrinsically-safe wiring. Description of special wiring methods can be found in the National Electrical Code ANSI/NFPA 70, Article 504 Intrinsically-Safe Systems. Check your state and local codes for additional requirements.

WARNING: REMOVE POWER FROM THE SYSTEM PRIOR TO INSTALLING OR SERVICING THE ISS-102.

Installation:

- 1. Mount the ISS-102 in a non-hazardous location on 35mm DIN rail, or by installing two #6 #8 screws into the surface mounting holes provided.
- 2. Connect wiring per SymCom's Control Drawing ISS-102C-M (on following page). Follow all hazardous code requirements while installing wiring to switch input terminals.

Operation:

The ISS-102C-M-LC (Latching Controller) is a dual-input, single output (form C), pump controller with latching/differential logic. Both input channels are compatible with switches (float, pressure, etc.) and resistive probes (fixed $100k\Omega$ threshold).

Each input channel is "active" when the corresponding switch is closed (or low resistance is detected, if using probes). When the LAG input (CH2) is activated, the output contact closes. Following latching/differential logic, the output contact remains closed until both the LEAD (CH1) and LAG (CH2) inputs are deactivated. The green RUN LED illuminates when the output relay is energized.

Wiring for the ISS-102C-M-LC input channels is as follows:

Pump Down Configuration:

Connect the LEAD input (CH1) to the low position, and the LAG input (CH2) to the high position. (Normally-open switches or resistive probes must be used.)

Pump Up Configuration:

Connect the LEAD input (CH1) to the high position, and the LAG input (CH2) to the low position. (Normally-closed switches only.)

Additional Features:

The input channels have a two-second debounce time delay to prevent nuisance actuation of the output relay.




Figure 1: Connection to Ground Plane



Capacitance and inductance of the field wiring from the intrinsically-safe equipment to the associated apparatus shall be calculated and must be included in the system calculations as shown in the table above. Cable capacitance, Ccable, plus intrinsically-safe equipment capacitance, Ci, must be less than the marked capacitance, Ca (or Co), shown on any associated apparatus used. The same applies for inductance (Lcable, Li and La or Lo, respectively). Where the cable capacitance and inductance per foot are not known, the following values shall be used: Ccable = 60pF/ft., Lcable = 0.2µH/ft.
